Any person, who acquires shares of the Company and becomes a Member of the Company after the dispatch of the Notice of AGM and holds shares as on the said cut-off date may obtain the User ID and Password by sending a request to [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in). If a person is already registered with NSDL for remote e-voting then existing User ID and Password can be used for casting vote. The facility for voting through poll paper shall be made available at the AGM. Members who have cast their vote by remote e-voting prior to the meeting may attend the meeting, but shall not be entitled to vote again at the AGM.
